- Certified copies of academics qualification, certification and professional memberships disclosed in the C.V. and the Form 3.
- Original latest report from Credit Bureau
- Declaration Form*

Every candidate wishing to nominate himself/herself or a representative, is invited to furnish the Bank with all required documents mentioned above, either by submitting by hand or via renowned international courier service to be delivered to the Bank's address:
